After completing his attorney training in 1996 and service as a public-service military legal officer in 1999, Mr. Yong Joo Park served as a judge at the Busan District Court until February 2001.

After retiring from the court in February 2001, Mr. Park joined Jipyong as a partner because he agreed with Jipyong's founding philosophy, which is to realize social responsibilities of experts and sharing spirit, and has been with Jipyong since then.

Mr. Park's expertise lies not just in civil and criminal cases, but also in administrative litigation related to Fair Trade Act violations, patent litigation related to machinery and construction and litigation in the fields of construction, real estate and taxation.
